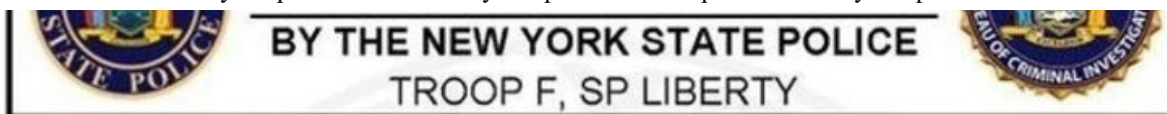
10 people wanted across NYS: Have you spotted them?

Once a week, the New York State Police ask the public a question: Can you help catch a wanted person?

Troopers release case details and mugshots every week of defendants wanted across the state in a feature called "Warrant Wednesday." By releasing information on Facebook and Twitter, state police hope the public can help troopers catch wanted defendants.
