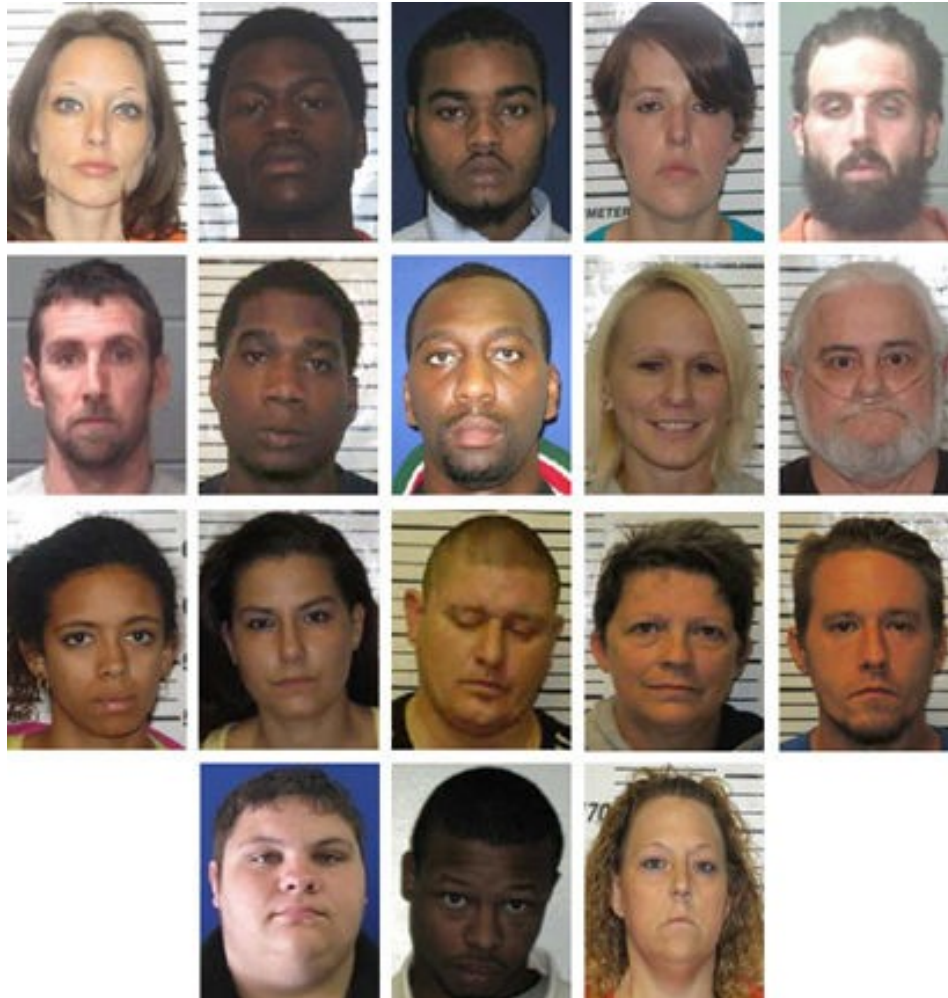

BEAUFORT — The County Sheriff's Office reported Friday four more arrests in Operation Winter Storm and 14 suspects wanted for narcotics charges.

In all, 69 suspects have been arrested during this anti-drug operation.
